The Senate began debating Obama's health care takeover plan. Most of the attention has been placed on several swing-vote Democrats who might oppose the bill. However, Democrats will likely find an excuse to support it.

Lieberman holds firm, President Obama will need one Republican to cross the aisle to provide the 60th vote needed to invoke cloture, cut off debate, and pass the bill.
